## **ORDER**

- 1. The Commission initiated the proceeding by directing the Petitioner to give a brief accord on the status of the replies on data gaps in the Petition submitted. The Representative of the Petitioner submitted that the replies to most of data gaps have already been submitted to the Commission. The remaining replies to the data gaps shall be submitted to the Commission by 27.12.2016.
- 2. In reply to query regarding submission of separate station wise Petition, APGCL submitted that it requires additional time for submission of separate ARR Petition for each Station.
- The Petitioner submitted that as per the prevailing procedure, Statutory Auditor issues certification for the Company as a whole and therefore the Petitioner shall submit independent Chartered Accountant (CA)/Cost Accountant certificate for Cost Allocation Statements.
- 4. As regards to the recovery mechanism for revenue gap arising out of truing up for FY 2014-15 & FY 2015-16, the Petitioner submitted that it has proposed the recovery of Revenue Gap from APDCL in 3 equal installments, however, it has been left open to the Commission to consider the appropriate period for recovery.
- 5. The Commission directed the Petitioner to submit the station wise Petitions on or before 22.12.2016 and all the pending replies on or before 27.12.0216 for admission and subsequent proceedings.

The decision on the admissibility of the Petition is kept reserved and subsequent order with regard to admission will be passed after compliance of the directions.
