**Sub: Draft AERC (Terms & Conditions for Determination of Multi Year
Tariff) Regulations, 2015.**

The existing AERC (Terms and Conditions for determination of Tariff) Regulations notified in the year 2006 need some changes, amendments and modifications in the prevailing situation of the power sector of the state of Assam in particular and India in general under Multi Year Tariff framework, also as specified in the National Electricity Policy, 2005 and National Electricity Policy, 2006 (as amended till date).

The Commission decided to draft the AERC (Terms and Conditions for determination of Multi Year Tariff) Regulations, 2015 in line with the CERC (Terms and Conditions of Tariff) Regulations, 2014 and these Regulations shall supersede the AERC (Terms and Conditions for determination of Tariff) Regulations, 2006.

The proposed AERC (Terms and Conditions for determination of Multi Year Tariff) Regulations, 2015 are placed in the official website of the Commission, www.aerc.gov.in in "Regulations" Page as previous publication under sub-section (3) of Section 181 of the Electricity Act, 2003. Any person who is likely to be affected by the provision of these Regulations may submit his comments / objections, suggestions to the Assam Electricity Regulatory Commission on or before 16th February, 2015.
