**(Provision of previous publication under Sub-Section 3 of Section 181 of
The Electricity Act, 2003)**

Sub: Draft AERC (Conduct of Business) Regulations, (First Amendment), 2017.

In exercise of the powers conferred under section 181 of the Act read with all relevant provisions of the Electricity Act 2003, the Assam Electricity Regulatory Commission had notified the AERC (Conduct of Business) Regulations, 2004 on 14th February, 2005. The Conduct of Business Regulations governs all matters for conduct of the proceedings before the Commission and discharge of its functions.

On the basis of experience gained since the AERC (Conduct of Business) Regulations, 2004 came into force, the Commission decided to review and update the above Regulations.

Accordingly, some provisions in the aforementioned Regulations are proposed to be amended and a draft AERC (Conduct of Business) Regulations (First Amendment), 2017 has been prepared and circulated among the stakeholders for their comments and suggestions.

The draft Regulations are also being uploaded in the official website of the Commission, www.aerc.gov.in in "Regulations" Page as previous publication under sub-section (3) of Section 181 of the Electricity Act, 2003. Any person/body corporate who is likely to be affected by the provision of these Regulations, may submit his comments / objections, suggestions to the Assam Electricity Regulatory Commission on or before 31st August, 2017.
