ORDER

- 1. A Hearing was held on 31.07.2017, on the petition no. 3 of 2017 filed by Suryataap Energies and Infrastructure Pvt Ltd (SEIPL) requesting for determination of final Tariff for their 5 MW Solar PV plant set up at IGC, Balipara, Assam.
- 2. As per direction of the Commission vide order dated 05.07.2017 and the Technical Validation Session (TVS) held on 20.07.2017, the petitioner submitted the latest generation details, Land lease agreement copy, Loan repayment statement from 20-06-2016 to 30-06-2017, Rfs/Rfp of tender document, comparative statement for selection of EPC contractor etc.
- **3.** APDCL mentioned that, the testing report of PV panels from NABL (National Accreditation Board for Testing and Calibration Laboratories) is to be provided by the petitioner. Also a justification including itemwise breakup is required for Rs 2 Cr shown in the balance sheet for Construction of buildings.

4. The Commission mentioned that, the petitioner had submitted copies of invoices raised by their EPC contractor i.e. M/s Hindustan EPC-Co Pvt Ltd. so, the petitioner was directed to submit the copies of original invoices from suppliers/vendors etc.

Petitioners reply:

The petitioner mentioned that, as M/s Hindustan EPC-Co Pvt Ltd. is a separate entity and SEIPL do not have access to their books of accounts so, they couldn't provide the original invoices and bills from the suppliers.

The Commission heard both the Petitioner & Respondent and ordered the following:

- 1. The Commission in the absence of original invoices and bills from the suppliers directed the petitioner to provide the following items within 10 days detailed below:
 - a) Name of the suppliers from where items were procured.
 - b) Date of procurement of items.
 - c) Technical specifications.
- 2. The Commission also directed the petitioner to submit full details of the constructed building & others with floor area, approach road, fencing, land site grading, leveling, civil costs etc.
- 3. The Commission directed the petitioner to publish the abridged form of the petition on 08.08.2017 in six local daily newspapers (Two English, Two Assamese, One Hindi and One Bengali), as per the format provided by the Commission. The Petitioner should get the draft notice approved by AERC.
- **4.** The Commission fixed the public hearing on **15.09.2017** at **11 AM** in the court room of AERC.
